Camp Details

Fees: Entering PK to K: \$160 per child per week. Entering 1st & 2nd Grades: \$180 per child per week. Entering 3rd & 4th Grades: \$200 per child per week. Children may attend 1 or 2 weeks in their age group.

Pre-registration and advance payment are required. Please make checks payable to "Essex County Parks." Cash, check and money orders are accepted. Minimum number of participants needed. Maximum 10 children per session. *T-shirt size is guaranteed if registered before June 7, 2021

Refund Policy: If you cancel 3 weeks prior to the first day of your child's scheduled week, a full refund will be issued to you. If you cancel less than 3 weeks, you will not be eligible for a refund. **All cancellations must be put in writing.** This policy will prevent any chance of an error being made. Cancellation for a family emergency or illness will be handled on a case-by-case basis.

Length and Setting: All camps run Monday through Friday and begin promptly at 9:30am. Sessions for children entering PK to K end at 12:30pm; sessions for children entering 1st to 4th Grades end at 1:30pm. Activities are held inside and outside the Environmental Center (there will be NO off-site trip this year). Weather permitting, all children are expected to explore the outdoors, prepare for wet/muddy conditions. **Please, for children's safety, kids are required to bring and wear a mask; open-toe shoes and flip-flops are not allowed.**

Due to an increase in allergy concerns, the Essex County Environmental Center is no longer providing snacks to campers. We are kindly asking campers to bring their own nut-free snack from home.

Campers are required to be signed in and out at the ECEC front deck each camp day by a parent/guardian. If you are unable to pick up your child(ren) at dismissal time, please coordinate with someone and advise the Center of the change. **Please note, a late fee of \$10.00 for every 15 minutes after a quarter past camp end time will be due at pick up.** Prior to camp, each child will receive information detailing how to prepare.
